5. That I shall always stand for and defend the respect, promotion, protection and fulfillment of human rights and freedoms for all Kenyans.
6. That I shall accommodate criticism and plurality of ideas and observe principles and practices of open, good and accountable governance.
7. That I shall support free and fair elections within the Party and in all electoral areas and processes in Kenya.
8. That I shall openly oppose and never practice or condone tribalism, nepotism and I shall ensure that allocation of resources and services are done fairly and equitably, and jobs on merit, through open and auditable processes.
9. That I shall actively support and practice zero tolerance to corruption.
10. That I shall be transparent in all my business practices and transactions and never allow my personal interest to prevail over the public interest.
11. That I shall always defend and protect public property and that I shall at all times, through appropriate platforms, expose any misuse of public office, money, property and investments irrespective of who is involved in acts of misuse;
